## Restrictions/Warnings

Allow an interval of 27-36 days between treatments.

## Crop Specific Information

Maxtima is a systemic fungicide with protectant and curative properties for disease control in managed amenity turf.

### Time of Application

For best results apply Maxtima as a protectant treatment. Applications can be made at any time on established managed amenity turf.

### Rate of Application

### Boom sprayers

Apply 1.5 litres per hectare of Maxtima in 300 to 600 litres of water per hectare.

### Knapsack sprayers

Apply 1.5 litres per hectare of Maxtima in 300 litres of water per hectare. Do not exceed 300 L/ha water volume for handheld spraying.

For smaller areas use Maxtima as follows:

	Per 100 m <sup>2</sup> turf	Per 300 m <sup>2</sup> turf	Per 500 m <sup>2</sup> turf
Maxtima required	15ml	45ml	75ml
Water required (litres)	3	9	15

## Mixing and Application

### Mixing

Maxtima can be applied through boom sprayers or via knapsack application. Application equipment should be calibrated before use.

Do not exceed 300 L/ha water volume for knapsack spraying.

Apply as a MEDIUM spray, as defined by BCPC.

Half fill the spray tank with clean water and start the agitation. SHAKE THE CONTAINER WELL before use and pour in the required amount of product. Rinse any empty containers thoroughly and add rinsings to the spray tank. Add the remainder of the water and continue agitation until spraying is completed.

When tank mixes are to be used, each product should be added separately to the spray tank, taking due note of any instructions given as to the order of mixing.

All tank mixes should be used immediately after mixing.
