APPLICATION RECOMMENDATION

Before applying Green Lawnger®, mow turf area to desired height. 1L of Green Lawnger covers between 0.01 - 0.03 hectares of turf. The wide coverage range is due to the type and condition of grass being treated, and turf colour desired. For autumn application on dormant turf, dilute 1L of Green Lawnger with 7 to 9 L of water. For a darker colour, a lower volume of water is recommended. Some experimentation may be required with ratios. For summer application on discoloured turf, dilute 1 L with 15 to 20 L of water. Rate depends on desired colour. For best results on discoloured areas, two applications are recommended to blend the applied area with the existing healthy turf.

Equipment Notice

BASF recommends the use of Teflon seals to aid in the prevention of leaks when using Green Lawnger in centrifugal pumps. Standard ceramic seals may leak during operation.

A spray shield is recommended for applications if overspray or drift is a potential problem. Avoid overspray on concrete, masonry, or any other objects where colour is not desired. Permanent staining may occur. Accidental overspray may be removed by a water rinse prior to drying. To prevent rub-off on clothing, allow Green Lawnger to dry fully prior to using treated area. Rinse spray tank, spray nozzles, and screens thoroughly with water immediately following use. For best results, use low to medium sprayer pressure.

Divot Mix Sand Colourant

Mix 200ml of Green Lawnger with the same volume of water. Add the solution to 50 kg of divot mix sand in a cement-type mixer.

CAUTION:

Keep out of reach of children. Do not take internally. In case of eye contact, flush with large amounts of water and consult a physician. In case of ingestion, dilute with water or milk and consult a physician. Do not re-use this container. Rinse contents into the spray tank and crush prior to disposal.
